Multiple Regional Workshops on Biological Diversity Laws would be conducted across India under the UNDP- GEF (Global ABS Project) on “Strengthening Human Resources, Legal Frameworks and Institutional Capacities to Implement the Nagoya Protocol”, for which NLSIU is the lead technical agency.
